#### 21/25. Apologies for absence

Cllr. R. Pearson-Bunt and Cllr. R. Phillips sent their apologies. Accepted by the Council.

The member of the public present wished to ask his question during Planning Matters to be discussed.

# 25/25. Approval of minutes of the Council meeting held on 16<sup>th</sup> April 2025 and the Annual Parish Meeting held on the 14<sup>th</sup> May 2025

All agreed to approve the minutes.

#### 26/25. Previous matters arising from the minutes not listed as separate items on this agenda:

## Boundary Stones/Ward Bridge

Cllr. Sturmer has written a letter outlining the historical context of parishes marking their boundaries and explaining the reasons why the Council wishes to have the Parish initials engraved on Ward Bridge. After reading the letter to all members, it was agreed that it should be forwarded to Devon Highways.

#### Devon Highways Updates

There was no further update. The Clerk to continue requesting updates on the issues already raised.

## • <u>Update Drake's Café nomination for Community Asset</u>

With regards to the cafe becoming a community asset, it appears unlikely this will proceed due to a lack of wider support and available funding. A local resident has raised concerns about the deteriorating condition of the building and, given its historical significance as a former Coaching Inn, has enquired whether it could be considered for listing? After discussion, it was agreed that the Clerk would contact West Devon Borough Council to raise concerns about the building's condition and to enquire what action, if any, could be taken.

#### • Discuss purchasing a portable projector

Cllr. Davies will bring her family's portable projector to the next meeting to test it out, prior to the Council deciding on whether to purchase its own projector.

# <u>27/25. To discuss submitting an appeal to BT following their decision to remove the telephone boxes at</u> Merrivale (Whitchurch) and Sampford Spiney

At the previous meeting, the Council agreed to support retaining the phone boxes as working phone lines, recognising their importance for life-saving purposes. Following further discussion, it was agreed to submit an

appeal, on the same grounds as before.

If the appeal is unsuccessful, all members agreed to adopt both phone boxes, as there was already community support expressed for doing so. Cllr. Cole agreed to act as the main contact for both phone boxes, if they are adopted and turned into community projects. The Clerk will investigate insurance arrangements for the boxes.

### 35/25. To consider the following planning application:

• West Devon - 1284/25/FUL & 1285/25/LBC — Lower Tor Farm, Whitchurch, PL19 9EQ Restoration & alterations to farmhouse, conversion of adjoining stable into ancillary accommodation & construction of detached garage. Demolition of agricultural buildings & conversion & extension of stone barn into holiday let.

A member of the public present at the meeting wished to express that, while they had no objection to the restoration and alterations of the main property, they opposed the proposed conversion and extension of the stone barn into a holiday let. Their main concern was the potential increase in traffic along the narrow lane, which is not wide enough for two vehicles to pass safely, particularly as holidaymakers may be unfamiliar with such rural roads. The member of the public was advised to submit their objection directly to the West Devon Planning Department.

After discussion, all members agreed to object to the application. The reasons cited were the need to safeguard the countryside and protect the interests of the local community. Concerns included loss of privacy for neighbouring properties, increased traffic accessing the site via a narrow road, and the potential for noise and disturbance.
